### Conference Overview

At the conclusion of this activity, learners will be able to:

- Differentiate between open, endovascular, and hybrid approaches for type A and B aortic dissection, including arch repair and Endo-Bentall procedures.
- Debate the indications, risks, and benefits of TEVAR versus fenestration, incorporating anatomical, clinical, and patient factors.
- Describe the full healthcare continuum for patients with connective tissue disorders including EDS, Marfan, and Loey's-Dietz.
- Incorporate the patient perspective, mental health awareness, and psychosocial support strategies into clinical care.
- Apply postoperative care pathways for open aortic repair, with emphasis on APP-led surveillance and complication recognition.
- Implement evidence-based pharmacologic strategies for hypertension and long-term medical management of aortic disease.

**Expected audience:** we expect an audience of **100** surgeons, cardiologists, anesthesiologists, IR physicians, APPs, pharmacists, nurses, and genetic counselors.


