COURSE OVERVIEW

AND TARGET AUDIENCE

In this one day in-person course, a team of multi-disciplinary experts will present on topics that are highly relevant for practicing gastroenterologists, hepatologists, primary care physicians, physician assistants, advanced practice providers, nurses, and anyone involved with providing patient care for liver disease before, during and after transplantation. Topics of focus include alcohol and the liver transplant candidate, patient experience, sarcopenic obesity and cirrhosis, transplant for hilar cholangiocarcinoma patients, use of GLP1As and bariatric surgery for patients with MASLD, anonymous living donation, socioeconomic, racial and gender disparities in transplant, indications for treatment and liver transplant for patients with cirrhosis.

DESIRED OUTCOMES

At the conclusion of the educational activity, the learner will:

- 1 Identify the indications for liver transplantation in the patient with substance abuse and the criteria and requirements for successful outcomes in this population
- 2 Describe the fundamental ideas behind anonymous living donor liver transplant and its potential impact on the future of liver transplantation.
- 3 Implement methods and practices to increase access to transplant for patients with a low socioeconomic status and other vulnerable populations.
- 4 Recognize new indications for liver transplantation related to malignancy and other oncologic indications.
- 5 Describe diagnostic procedures and treatments for patients with liver-pulmonary disease prior to liver transplant.
- 6 Understand our unique approach to liver transplant evaluation for patients who may otherwise have contraindications to transplant.
- 7 Delineate the multifaceted approach to each liver transplant candidate and the requirements for patients with nonstandard listings for alcohol hepatitis, HCC outside of Milan criteria, low meld/ PHTN.
- 8 Apply management strategies for cirrhotic patients in the inpatient and primary care setting.
- 9 Consider using living donation as a strategy for transplant and when to refer a patient for evaluation.

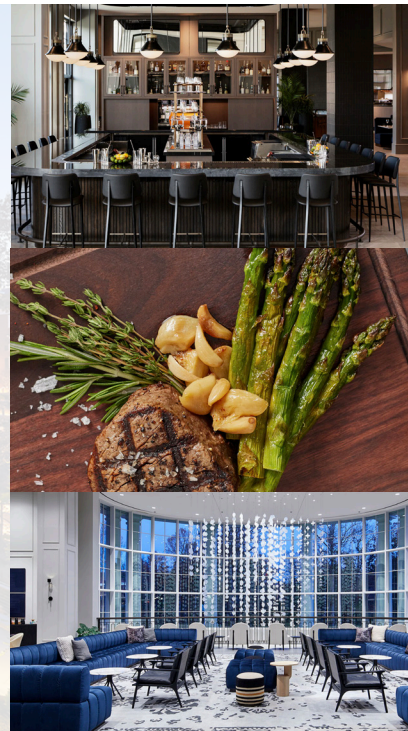
